A. There are many things you can do to get back into school. First of all, if you are entitled

to veterans benefits, usually the only thing you need to take to the campus veterans office are your DD-214

discharge papers. You can apply online for your VA education benefits at www.va.gov. If you have in mind the degree or certificate you are pursuing, make sure you find a college, university or trade school that offers that program. If you are not eligible for veterans benefits, and not sure what degree you want to pursue, there is a great program that is completely free, called Veterans Upward Bound Program

(www.navub.org). The program assists eligible veterans in developing, improving and extending educational access and opportunities through academic needs

assessment, instruction, enrichment, and other education support activities. VUB will give you a test to find out just what skills you need to enhance your academic experience. Once you have completed the test, you will be enrolling in college prep classes.

VUB enrollment criteria include:

- 1. Must be a U.S. military veteran with 181 or more days of active-duty service and discharged on/after Jan. 31, 1955, under conditions other than dishonorable.
- Qualify as low-income according to guidelines published annually by the U.S. Department of Education, and/or a first-generation college graduate.
- 3. Must demonstrate academic need.
- 4. Meets other local eligibility criteria as noted in the local VUB project's approved grant proposal, such as county of residence, etc.
